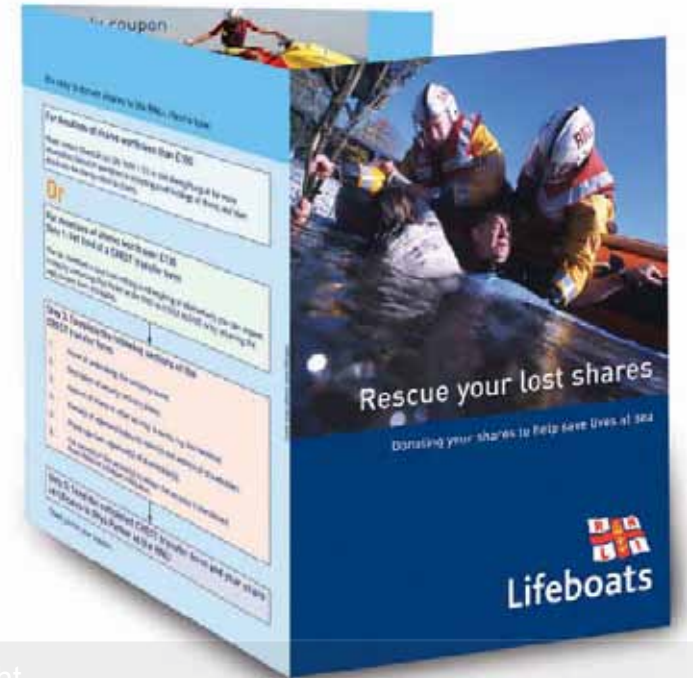
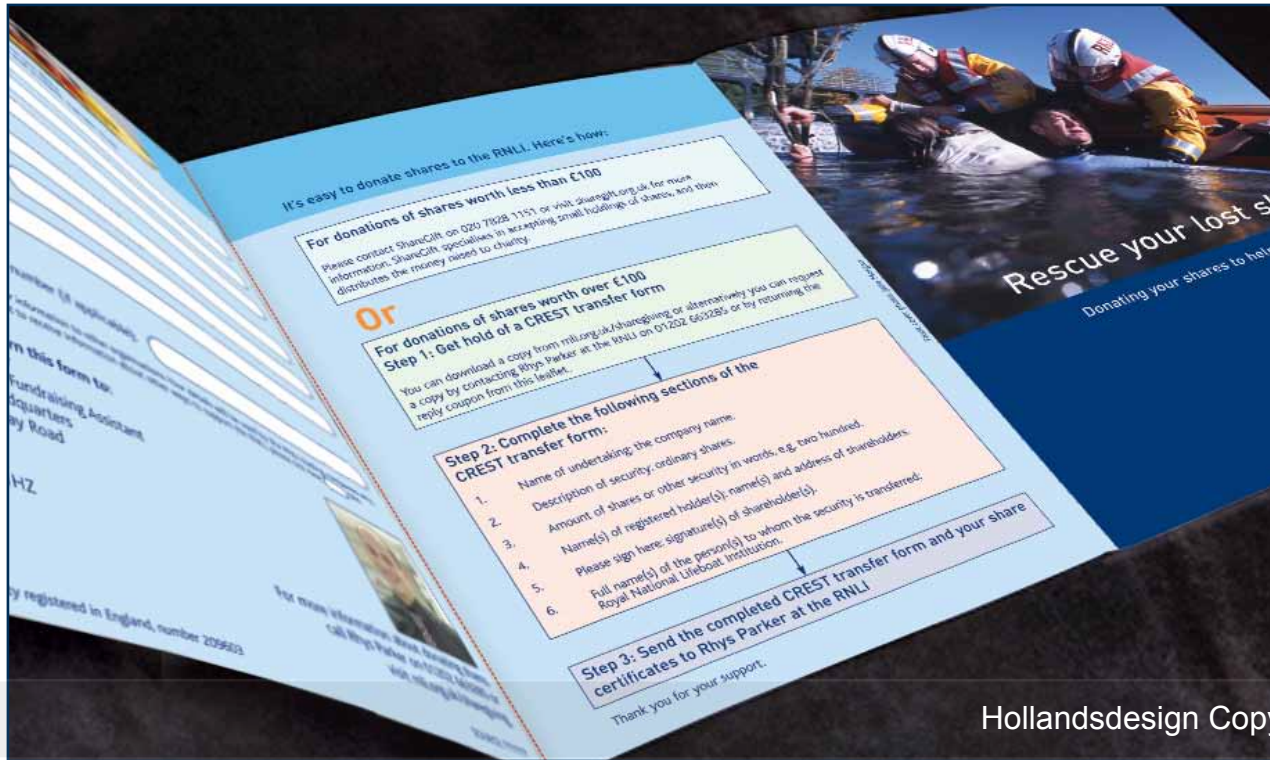

Doing your share

Did you know that you can support the RNLI by donating your unwanted shares? Share donations are increasingly becoming a valuable source of income for the RNLI, as we can turn them into something tangible to support our lifesaving work.

It may well be that you have a number of unwanted shares that would cost you almost as much to sell as they are worth, or perhaps you have received small shares that you would like to donate or you are simply looking for a tax-efficient way of giving to charity.

The good news is that when you donate shares to the RNLI you will be entitled to relief on Income Tax and Capital Gains Tax (CGT) on the value of your donation. This may be important to you if you have already reached, or are likely to reach, your CGT annual limit. To make the most of this opportunity, please speak to your financial adviser or local tax office, as the RNLI is unable to advise on personal tax issues.

Donating your shares is very easy and there are two ways to make a share donation to benefit the RNLI. Depending on the quantity of shares received, as follows:

Reaping dividends for the RNLI with shares worth over £100

The RNLI is always grateful for donations of shares, large or small. If you are unsure of the value of your shares, it's best to check the investment pages of your newspaper or with your financial adviser.

For shares worth more than £100 you can send them directly to us to sell through our stockbroker, rather than speculating with dividends, we sell the shares as soon as possible so that the proceeds can be used to help save lives at sea.

In donate in this way, all you need to do is complete a CREST transfer form, which you can download from mtl.org.uk/sharing, or request by completing the reply coupon on this leaflet and send it with your share certificates to:

Keep your small shares buoyant for the RNLI

The RNLI welcomes donations of smaller amounts of shares too, although if your shares are worth less than £100 it's possible that it wouldn't be cost-effective for us to sell them direct. To get around this we work with charity share donation expert ShareGift, a registered charity that specialises in accepting small holdings of shares.

You may have a few shares from privatisations or inheritance (IPO) or perhaps your investments have fallen in value - ShareGift can help even if you have just one or two shares.

Once ShareGift has collected enough of each share it will then distribute the money raised to charity. When ShareGift makes donations it is guided by suggestions from the donors and from those who help ShareGift operate. So when you donate shares please nominate the RNLI as the charity you would like to support. In the last 10 years, ShareGift has donated over £30,000 to the RNLI.

ShareGift makes no charge for you to use its service and for more information you can contact ShareGift direct.
